Location

The premises are located on Tinsley Street, Great Bridge. Great Bridge Town Centre is within 400 yards and the Motorway Network is accessible via Junctions 1 and 2 of the M5 at West Bromwich and Oldbury.

The unit is of steel portal framed construction with brick/blockwork and insulated profiled sheeted walls surmounted by a pitched, insulated profiled sheeted roof incorporating filon roof lights. A suspended ceiling has been fitted. Height to underside suspended ceiling - 4.28 m. (14') approx. Access is via an electrically operated roller shutter door. An office and a kitchen and toilet are included. A steel framed mezzanine floor is included. Additional stores are located above the offices.
